## **Equipment Utilized**

Safety Unlimited, Inc. maintains a large inventory of state-of-the- art education and training equipment designed specifically for the training of Emergency Medical Services (EMS) personnel. This equipment simulates equipment currently used in the field by EMS providers on a state and national level. The equipment includes specialized anatomical models and human-like manikins. Defibrillators are available for hands-on training. Equipment is also utilized for learning to manage airways and ventilate patients, treat shock, and administer medications on a limited basis. Students have access to the internet through a free wi-fi connection.

Outside of class time, current students will have access to all equipment and resources for purposes of practice and study during business hours. In order to access the equipment and learning resources, students must come to the front office and speak to office staff. Office staff will assist students in signing out all EMT-related equipment for use outside of class hours.

Current Initial EMT students also have access to free tutoring provided they call and make an appointment during normal business hours.



# **Classroom Courses**

Our EMT courses prepare students to render pre-hospital basic life support at the scene of an emergency, during transport of the sick and injured, or during inter-facility transfer. They introduce topics in the field of emergency care including anatomy, physiology, patient assessment, medical and traumatic emergencies, and injuries. Successful completion of the EMT course will prepare the student to take the National Registry of EMT (NREMT) Basic Exam and becoming state certified (depending on state requirements).



#### **Emergency Medical Technician (EMT Initial)**

#### **160 hours (maximum student enrollment - 24 per session)**

This course fulfills all the training requirements set forth by the State of Arizona for Emergency Medical Technicians (EMT). All students are expected to participate in both skills and lecture. The class prepares the student to render pre-hospital basic life support at the scene of an emergency, during transport of the sick and injured, or during inter-facility transfers. Students will cover selected topics and anatomy, physiology, patient assessment, and emergency treatment. Theoretical learning is followed by corresponding skills training. Students will be required to take quizzes on each chapter, as well as 4 block exams and a final Exam. All quizzes and tests will be given in multiple choice format. Students must complete a minimum of 130 hours of instruction in order to be eligible to complete the course.

Upon successful completion of the course, students will be eligible to take the National Registry certification exam, which serves as the current certifying exam for both the National Registry of EMTs (NREMT) and the State of Arizona. Once students pass the NREMT exam and obtain an NREMT card, they will be nationally certified Emergency Medical Technicians. Students will then be able to register in the state of their choosing. Additional specific state requirements may apply.

#### **Emergency Medical Technician (EMT) Skills Testing**

State Skills Certification: This course is designed to provide skills verification for NREMT and State requirements. Upon demonstrating competency in the following skills (what skills?), the student will receive a completed EMT Skills Competency Verification Form.

#### **EMT Skills Training / Practice**

These courses provide Emergency Medical Technicians with an opportunity to revisit their skills with a certified instructor before challenging their actual skills testing. The training consists of 8 hours of intensive skills training while the practice session provides a dry run through the testing process with a skills proctor guiding the student.



## **American Heart Association Courses**

#### **CPR Instructor - Healthcare Provider (BLS)**

This course enables an instructor to teach the following:

- BLS Healthcare Provider CPR
- Heartsaver CPR/AED
- Heartsaver Pediatric First Aid/ CPR/ AED
- Heartsaver First Aid
- All Friend and Family Courses

#### Friends And Family CPR

This is a video-based course that teaches adult Hands Only CPR, AED use, child CPR and AED use, and infant CPR. It also teaches how to relieve choking in an adult, child, or infant. This Family and Friends CPR course is for members of the general public who want to learn CPR.

#### **Basic Life Support (BLS) Provider**

This course is taught using the new science in the 2020 American Heart Association Guidelines for Cardiopulmonary Resuscitation and Emergency Cardiovascular Care. With this training, a two-year Healthcare Provider Initial Training certification is issued.

#### Heartsaver Adult/Child/Infant CPR With AED

This is a classroom-based, video-driven course led by an American Heart Association Heartsaver or Basic Life Support (BLS) Instructor. Upon successful completion of all course requirements, students receive a Heartsaver course completion card in CPR and AED, valid for two years.

#### **Heartsaver First Aid**

This course teaches how to manage illness and injuries in the first few minutes until professional help arrives. The course includes General Principles, Medical Emergencies, Injury Emergencies and Environment Emergencies.

#### Heartsaver First Aid/CPR/AED

This course is designed for employee training at companies, corporations, businesses, or other entities. It is designed for employees or designated first responders who have a duty to respond to a first aid or cardiac emergency because of job responsibilities or regulatory requirements.



#### Heartsaver Pediatric First Aid/CPR/AED

The course is designed for those involved in child care who have a duty to respond to a first aid emergency because of job responsibilities or regulatory requirements, such as child care workers, teachers, foster care providers, camp counselors, youth organizations, and coaches.

#### **Heartsaver / Friend and Family Instructor**

This course gives the instructor the ability to teach the following courses:

- Heartsaver CPR/ AED
- Heartsaver Pediatric First Aid/ CPR/ AED Heartsaver First Aid
- All Friends and Family courses

#### **ACLS Initial Training**

#### 2 Day Course

ACLS is based on simulated clinical scenarios with hands-on participation through learning stations where students will practice essential skills individually, as part of a team, and as a team leader. Realistic simulations reinforce the key concepts: proficiency in Basic Life Support care, recognizing and initiating early management of peri- arrest conditions, managing cardiac arrest, identifying and treating ischemic chest pain and acute coronary syndromes, recognizing other life threatening clinical situations (such as stroke) and providing initial care, ACLS algorithms and effective resuscitation team dynamics.

#### **ACLS Instructor Course**

#### 6 hours on-line | 4 to 5 hours in the classroom

Students must have a current ACLS Provider card. This course includes core instructor instruction, ECC Guidelines, ACLS Instructor materials (instructor book, DVDs, stopwatch and posters).

#### **ACLS Refresher Training**

#### **1 Day Course**

This is a one-day renewal course. ACLS is based on simulated clinical scenarios with hands-on participation through learning stations where students will practice essential skills individually, as part of a team, and as a team leader. Realistic simulations reinforce the key concepts: proficiency in Basic Life Support care, recognizing and initiating early management of peri-arrest conditions, managing cardiac arrest, identifying and treating ischemic chest pain and acute coronary syndromes, recognizing other life-threatening clinical situations (such as a stroke) and providing initial care, ACLS algorithms, and effective resuscitation team dynamics.



#### **Basic ECG Course**

This class is an instructor-led, classroom-based ECG course. It is an essential resource for training healthcare professionals who participate in the management of cardiopulmonary arrest or other cardiovascular emergencies. This includes personnel in emergency response, emergency medicine, intensive care, and critical care units, such as physicians, nurses, paramedics, and others who require this specialized knowledge for their job. This course is a pre-requisite course for ACLS and for PALS.

The scope of the class includes:

- Basic electrophysiology Normal ECG measurements Basic arrhythmias
- Administration of appropriate drugs within the ACLS algorithms
- Course length is approximately 6 hours. The course is intended for credentialed healthcare providers.

#### **PALS Initial Training**

#### 2 Day Course

The PALS course is to aid pediatric healthcare providers in developing the knowledge and skills necessary to efficiently and effectively manage critically ill infants and children. The skills taught include recognition and treatment of infants and children at risk for cardiopulmonary arrest; the systematic approach to pediatric assessment; effective respiratory management; defibrillation and synchronized cardioversion; intraosseous access and fluid bolus administration, and effective resuscitation team dynamics.

#### **PALS Instructor Course**

This course instructs current PALS Provider cardholders to become instructors. The course provides ECG Guidelines, Core Instructor course, and all PALS Instructor materials.

#### **PALS Refresher Training**

#### **1 Day Course**

The Refresher PALS course is to aid pediatric healthcare providers in developing the knowledge and skills necessary to efficiently and effectively manage critically ill infants and children. The skills taught include recognition and treatment of infants and children at risk for cardiopulmonary arrest; the systematic approach to pediatric assessment; effective respiratory management; defibrillation and synchronized cardioversion; intraosseous access and fluid bolus administration, and effective resuscitation team dynamics.

## **American Heart Association Courses**

#### Heart Code ® ACLS – Part 1 Online

This is a web-based, self-paced instructional program that allows students to assess and treat patients in virtual healthcare settings following the ACLS algorithms. This allows students to apply their knowledge to real-time decision-making and skill development.

Debriefing and coaching are provided immediately after each simulation to facilitate learning. The course is a convenient alternative to taking the ACLS course. The online course allows students to train at their own pace and schedule. Heartcode ACLS may be used for initial or renewal certification. Features of this course include: the importance of continuous, high quality CPR, team dynamics and communication, immediate post-cardiac arrest care, airway management, related pharmacology.

Students will have access to all information in the online course for 24 months following activation of the course key.

#### **American Heart Association Skills Portion of E-Learning**

This course is required for the American Heart Association Heartcode ACLS E-Learning course. Students must have American Heart Association certificate of completion for online training present at the time of the skills session. Skill sessions will be scheduled upon completion of the online course.

#### **PALS Heartcode Part 1**

Heartcode Part 1 is a self-directed interactive course intended for healthcare professionals who require a PALS Provider course completion card, as well as for nurses and emergency medical services personnel seeking continuing education credit. Students have access to the course for one year from initial license activation.

#### **PALS Heartcode Skills Session**

This course is required for the American Heart Association PALS Heartcode Part 1. It may be used for initial or renewal certification. An American Heart Association certificate of completion must be presented at the time of the skills session. Skills sessions will be scheduled upon completion of the online course.



#### **American Heart Association Skills Portion For Online Courses**

Required skills sessions for all American Heart Association e-learning courses. Online elearning courses include:

- BLS for Healthcare Provider;
- Heartsaver First Aid;
- Heartsaver CPR and AED; and
- Heartsaver First Aid with CPR and AED

Students must have an American Heart Association certification of completion for online training present at the time of skills session.

#### For Healthcare Providers Online Part 1

This web-based, self-directed course uses case-based scenarios and interactive lessons to teach students about both single-rescuer and basic life support. This includes promptly recognizing several life-threatening emergencies, providing high quality chest compressions, delivering appropriate ventilations and providing early use of an AED. The course may be used for initial or renewal BLS for Healthcare Provider course completion. Students must complete all three (3) parts of the course:

- Part 1- Online course: This includes a written exam after which students will receive a Part 1 certificate of completion, which must be presented for Parts 2 and Part 3;
- Part 2- Hands-on skills session with an authorized American Heart Association BLS instructor; and
- Part 3- A skills test with an authorized American Heart Association BLS instructor.

This course is designed for healthcare professionals and other personnel seeking an alternative method for completing an initial or renewal BLS for Healthcare Providers course.

#### **Heartsaver Bloodborne Pathogens**

This course is designed for persons with a chance for occupational exposure to blood or blood-containing material.

#### **Heartsaver CPR and AED Online – Part 1**

This course teaches the basics in CPR and AED use. It is a two (2) hour on-line course and a 60-minute skills session at the training center. Skill session is sold separately.



#### Heartsaver First Aid Online – Part 1

This course is designed for anyone who needs basic first aid training. It includes:

- First aid basics;
- Medical emergencies (including adult chocking) Injury emergencies; and
- Environmental emergencies

This course is 1 to 2 hours with a 60-minute skills session at the training center. Skills session sold separately. The certification is valid for 2 years.

#### Heartsaver First Aid With CPR and AED Online – Part 1

This course is a comprehensive safety training for the workplace. It includes:

- First aid basics;
- Medical emergencies (including adult choking) ;Adult CPR and AED use;
- Injury emergencies;
- Environmental emergencies; and
- Optional topics include child/infant CPR with AED, Child/infant choking.

Duration of online course (2.5 hours); skills session at the training center (60 minutes). The skills session is sold separately. Certification is valid for 2 years.

# California / Arizona Approved EMS Refresher Courses

#### **Online US DOT 24 Hour EMT Refresher Course**

The EMT is able to complete the required 24-hour refresher training online and at any time. This course meets local and state requirements for California. The course qualifies as distance education for the NREMT. This course is not approved for Arizona Certified EMT-B. Check your state EMS Authority for any possible additional requirements. Students must attend all 24 hours of class time in order to be eligible for the continuing education credit.

#### **Paramedic Refresher**

The National Standard Paramedic Refresher course adheres to the 2011 Paramedic Curriculum. The Paramedic is able to complete the required 48-hour refresher training online and anytime. This course meets local and state requirements for California. The course qualifies for distance education for the NREMT. Check your State EMS Authority for any possible additional requirements.

#### **ALS/BLS Continuing Education Online**

Continuing education shall be in any topics contained in the United States Department of Transportation EMS Education Standards from 2021. All approved CE shall contain a written and/or skills competency-based evaluation related to the course, class or activity objectives. Students may also come in during normal business hours and practice with the equipment that is available, provided they do not disturb any ongoing classes. Additional tutoring is available for non-current initial EMT students for an additional fee.

Amenities include a coffee machine, a community refrigerator and microwave for students who want to bring food to the school.

All students will be required to show proof of all immunizations, vaccinations (including COVID-19), and proof of current TB Testing. Students will be required to follow all current County, State, and Federal requirements.

#### **Job Placement**

Safety Unlimited, Inc. does not provide any kind of job placement or guarantee of employment once a student successfully completes a program. Educators can provide direction, suggestion, and letters of recommendation if applicable, but the responsibility of obtaining employment rests solely with the student.

#### **Student Conduct & Achievement**

Initial EMT students are required to wear a complete uniform to class. Patches must be properly placed, and uniforms should be clean and neat.

#### **Entrance Requirements**

Students are required to have a minimum reading proficiency at the 9th grade level. All students are required to have access to a computer with internet access, sound, camera, and color monitor. For the Initial Emergency Medical Technician class, all students must be 17 ½ years old at the time of registration.

As a prospective student, you are encouraged to review this catalog prior to signing an enrollment agreement.

#### **College Credit and Degree Programs**

Safety Unlimited, Inc. does not accept any previous college credits from other colleges towards their EMS programs.



#### NOTICE CONCERNING TRANSFERABILITY OF CREDITS AND CREDENTIALS EARNED AT OUR INSTITUTION

The transferability of credits you earn at Safety Unlimited, Inc. is at the complete discretion of an institution to which you may seek to transfer, Acceptance of the credits you earn in the initial EMT program is also at the complete discretion of the institution to which you may seek to transfer. If the credits that you earn at this institution are not accepted at the institution to which you seek to transfer, you may be required to repeat some of all your coursework at that institution.

For this reason, you should make certain that your attendance at this institution will meet your educational goals. This may include contacting an institution to which you may seek to transfer after attending Safety Unlimited, Inc. to determine if your credits will transfer.

Safety Unlimited, Inc. does not offer any programs that offer a degree to students upon completion. All students who complete the Initial EMT course are eligible to sit for the NREMT certification exam upon successful completion of the course, but the school does not award EMT certification.



#### Grading

Completion of the Emergency Medical Technician (EMT) program at the Safety Unlimited, Inc. is subject to the following criteria:

- Maintaining an 80% grade point average (GPA)
  - o 100% 90% **A**
  - o 89% 80% B
  - o 79% 70% C
  - o 69% 60% D
  - o 59% or below F
- Completion of the course Final Exam with a minimum grade of 80%.
- Active participation in practice sessions and successful completion of all Skills exams based on National Standards.
- Compliance with all attendance requirements.

#### Attendance

Students are expected to attend classes as scheduled as they would be expected to be present during employment. Students must attend at least 130 hours of classroom time during the didactic phase. There will be assigned make-up work for all classroom hours missed. Make-up work will not be accepted or counted as hours or class attendance. Instructional hours will need to be made up with attendance in another class.

Tardiness is a disruption of the learning environment and is discouraged. Any student arriving to class more than 5 minutes tardy will be docked ¼ hour of class attendance.

Leave of Absence - Written requests for leaves of absence will be considered and such leaves may be granted to students at the discretion of the school. However, all course work must be completed within 6 months of course start date.

#### **Dismissal and Suspension**

If students do not maintain passing grades, students will be dismissed from the current course. If students do not maintain professional conduct, they will be dismissed from the coursework. In addition, students may be dismissed for engaging in any of the behaviors not considered appropriate conduct in the student conduct and achievement section.

Any student who does not pass, or any student who is caught attempting to be dishonest with the tests will be immediately dismissed from the program with no refund.



#### Tuition

All tuition for courses is due at the time of registration. Initial Emergency Medical Technician (EMT) registration can be completed with full tuition due no later than 5 days prior to the start of class sessions.

Course textbook will be provided to each student as part of tuition. Optional workbook or online companion site will be available for an additional cost.

#### **Student Records**

Student records will be maintained for a minimum of three (3) years from the last date the student is enrolled at Safety Unlimited, Inc. Students may request a formal copy of their transcripts by submitting a request in writing, by either mail or email, for the period of time and class(es) for which they would like a record. Certain confidential and sensitive records, such as test answers, will not be given, though students may request the results of the tests taken at any time, and may request a record of any information the school is required to provide by law.
