

### **PROGRAM OBJECTIVES**

**EMT Initial: The objective of this program is to complete all didactic, psychomotor, and clinical competencies with a score of at least 80% to become eligible to sit for the NREMT exam and further obtain state certification, if desired and/or needed.**

**EMT Refresher: The objective of this program is to complete all didactic and psychomotor competencies with a score of at least 80% to renew a current or lapsed EMT certification.**

**EMR Initial: The objective of this program is to complete all didactic and psychomotor competencies with a score of at least 80% to become eligible to sit for the NREMR exam and further obtain state certification, if desired and/or needed.**

## Description of Courses

**Prepares students to render pre-hospital basic life support at the scene of an emergency, during transport of the sick and injured, or during inter-facility transfer. Introduces topics in the field of emergency care including anatomy, physiology, patient assessment, medical and traumatic emergencies, and injuries. Successful completion of this course will prepare the student to take the National Registry of EMT (NREMT) Basic Exam and becoming state certified (depending on state requirements).**

## Equipment Utilized

**Safety Unlimited, Inc. has a well-maintained training facility in Simi Valley that includes a climate-controlled classroom and office space, microwave, refrigerator, coffee, and other drinks provided, as well as bottled water. We also maintain a large inventory of state-of-the- art education and training equipment designed specifically for the training of Emergency Medical Services (EMS) personnel. This equipment simulates equipment currently used in the field by EMS providers on a state and national level. The equipment includes specialized anatomical models and human-like manikins. Defibrillators are available for hands-on training. Equipment is also utilized for learning to manage airways and ventilate patients, treat shock, and administer medications on a limited basis. Students have access to the internet through a free wi-fi connection. Outside of class time, current students will have access to all equipment and resources for purposes of practice and study during business hours. In order to access the equipment and learning resources, students must come to the front office and speak to office staff. Office staff will assist students in signing out all EMT related equipment for use outside of class hours.**



## **TUTORING**

**Current Initial EMT students also have access of up to 10 hours of free tutoring, provided they call and make an appointment during normal business hours. Any additional requests for tutoring will be charged at a rate of \$50.00/hour.**

**Current Initial EMR students also have access of up to 5 hours of free tutoring, provided they call and make an appointment during normal business hours. Any additional requests for tutoring will be charged at a rate of \$50.00/hour.**

## **ELIGIBILITY FOR CERTIFICATION**

### **EMR:**

**NREMT: Other than successfully completing the primary education program, the NREMT requires passing of their cognitive exam.**

**California: California does not have any requirements as this is not a certification recognized in this state.**

### **EMT:**

**NREMT: Other than successfully completing the primary education program, the NREMT requires passing of their cognitive exam.**

**California: Must be at least 18 years of age and pass a background investigation via Live Scan**



## **EMERGENCY MEDICAL RESPONDER (EMR Initial)**

**(64 hours) (maximum student enrollment - 24 per session)**

**This course fulfills all the training requirements set forth by the State of California for Emergency Medical Responders (EMR). All students are expected to participate in both skills and lecture. The class prepares the student to render pre-hospital basic life support at the scene of an emergency prior to the arrival of professional EMS personnel. Students will cover selected topics and anatomy, physiology, patient assessment, and emergency treatment.**

**Theoretical learning is followed by corresponding skills training. Students are required to take quizzes on each chapter, as well as block exams and a final Exam. All quizzes and tests will be given in multiple choice format. Students must complete a minimum of 64 hours of instruction to be eligible to complete the course.**

**Upon successful completion of the course, students will be eligible to take the National Registry certification exam, which serves as the current certifying exam for both the National Registry of EMTs (NREMT) and the State of California. Once students pass the NREMT exam and obtain an NREMR card, they will be nationally certified Emergency Medical Responders. Students will then be able to register in the state of their choosing. Additional specific state requirements may apply.**

**The U.S. Department of Labor Standard Occupational Classification Code for EMR is 29-2040.**



## **EMERGENCY MEDICAL RESPONDER (EMR Refresher)**

**(16 hours) (maximum student enrollment - 18 per session)**

**This course fulfills all the training requirements set forth by the State of California for Emergency Medical Responders (EMR). All students are expected to participate in both skills and lecture. Students must have current EMR certification to take this course. EMR must be renewed every 2 years prior to the date of expiration.**

## **EMERGENCY MEDICAL TECHNICIAN (EMT Initial)**

**(170 hours) (maximum student enrollment - 32 per session)**

**This course fulfills all the training requirements set forth by the State of California for Emergency Medical Technicians (EMT). All students are expected to participate in both skills and lecture. The class prepares the student to render pre-hospital basic life support at the scene of an emergency, during transport of the sick and injured, or during inter-facility transfers. Students will cover selected topics and anatomy, physiology, patient assessment, and emergency treatment. Theoretical learning is followed by corresponding skills training. Students are required to take quizzes on each chapter, as well as 4 block exams and a final Exam. All quizzes and tests will be given in multiple choice format. Students must complete a minimum of 170 hours of instruction to be eligible to complete the course.**

**Upon successful completion of the course, students will be eligible to take the National Registry certification exam, which serves as the current certifying exam for both the National Registry of EMTs**

**(NREMT) and the State of California. Once students pass the NREMT exam and obtain an NREMT card, they will be nationally certified Emergency Medical Technicians. Students will then be able to register in the state of their choosing. Additional specific state requirements may apply.**

## **EMERGENCY MEDICAL TECHNICIAN (EMT Refresher)**

**(24 hours) (maximum student enrollment - 24 per session)**

**This course fulfills all the training requirements set forth by the State of California for Emergency Medical Technicians (EMT) and applies towards the National Registry of EMT's. All students are expected to participate in both skills and lecture. Students must attend all 24 hours and pass the written and skills exams to complete the course.**

Foreign students may show proof of language proficiency, such as a passing score on TOEFL (Test of English as a Foreign Language). No English proficiency tests will be administered by Safety Unlimited, Inc. and the TOEFL should be taken at a third-party agency.**

## SPECIAL NEEDS

**Safety Unlimited, Inc. will provide reasonable and appropriate accommodations for students with documented disabilities. ## ADDITIONAL SERVICES

**In addition to its classes, Safety Unlimited, Inc. offers some additional services to its students. The school offers limited free tutoring for its Initial EMR/EMT students during business hours (subject to availability). Students are required to make an appointment with the office staff prior to obtaining tutoring.**

**Students may also come in during normal business hours and practice with the equipment that is available, provided they do not disturb any ongoing classes. Additional tutoring is available for non-current initial EMT students for an additional fee.**

**Amenities include a coffee machine, a community refrigerator and microwave for students who want to bring food to the school.**

## IMMUNIZATIONS / VACCINATIONS

**All students will be required to show proof of all immunizations, vaccinations, and proof of current TB Testing. Students will be required to follow all current County, State, and Federal requirements.**

## JOB PLACEMENT

**Safety Unlimited, Inc. does not provide any kind of job placement or guarantee of employment once a student successfully completes a program. Educators can provide direction, suggestion, and letters of recommendation if applicable, but the responsibility of obtaining employment rests solely with the student.**



## **STUDENT CONDUCT and ACHIEVEMENT**

**Students are expected to conduct themselves in a mature, responsible manner at all times. Safety Unlimited, Inc. prides itself upon encouraging students to achieve their full potential. Students are expected to do their own work, do their best work, and to take initiative to receive assistance if they are having trouble. Students are encouraged to call and make an appointment for limited free tutoring and assistance during business hours to help them achieve their goal of becoming a better person through the skills they learn while at Safety Unlimited, Inc.**

## **STUDENT DRESS CODE**

**Initial EMT students are required to wear a complete uniform to class. Uniforms shall be clean and neat.**

## **ENTRANCE REQUIREMENTS**

**There are no pre-entrance examinations to qualify for Safety Unlimited, Inc. courses. All students are required to have access to a computer with internet access, sound, and a color monitor. For the Initial Emergency Medical Technician class, all students must be 18 years old and have a valid Basic Life Support (BLS) CPR Card at the time of first day of class.**

**As a prospective student, you are encouraged to review this catalog prior to signing an enrollment agreement. You are also encouraged to review the School Performance Fact Sheet, which must be provided to you prior to signing an enrollment agreement**

## **College Credit and Degree Programs**

**Safety Unlimited, Inc. does not accept any previous college credits from other colleges towards their EMS programs.**



## **NOTICE CONCERNING TRANSFERABILITY OF CREDITS AND CREDENTIALS EARNED AT OUR INSTITUTION**

**The transferability of credits you earn at Safety Unlimited, Inc. is at the complete discretion of an institution to which you may seek to transfer. Acceptance of the certificate you earn in the educational program is also at the complete discretion of the institution to which you may seek to transfer. If the certificate that you earn at this institution is not accepted at the institution to which you seek to transfer, you may be required to repeat some of all your coursework at that institution. For this reason, you should make certain that your attendance at this institution will meet your educational goals. This may include contacting an institution to which you may seek to transfer after attending Safety Unlimited, Inc. to determine if your credits will transfer.**

**Currently, Safety Unlimited, Inc does not have any transfer or articulation agreements with any other college or university.**

**Safety Unlimited, Inc. does not offer any programs that offer a degree to students upon completion. All students who complete the Initial EMT course are eligible to sit for the NREMT certification exam upon successful completion of the course, but the school does not award EMT certification.**



## GRADING

**Completion of the Emergency Medical Technician (EMT) program at the Safety Unlimited, Inc. is subject to the following criteria:**

- **Maintaining an 80% grade point average (GPA)**

**90%-100% A**

**80%- 89% B**

**70%- 79% C**

**60%- 69% D**

**< 60% F**

- **Completion of the course Final Exam with a minimum grade of 80%.**
- **Active participation in practice sessions and successful completion of all Skills exams based on National Standards.**
- **Compliance with all attendance requirements.**



## ATTENDANCE

**Students are expected to attend classes as scheduled as they would be expected to be present during employment. Students must attend at least 146 hours of classroom time during the didactic phase. There will be assigned make-up work for all classroom hours missed. Make-up work will not be accepted or counted as hours or class attendance. Instructional hours will need to be made up with attendance in another class.**

**Tardiness is a disruption of the learning environment and is discouraged. Any student arriving to class more than 5 minutes tardy will be docked  $\frac{1}{4}$  hour of class attendance.**

**Leave of Absence - Written requests for leaves of absence will be considered and such leaves may be granted to students at the discretion of the school. However, all course work must be completed within 6 months of course start date.**

## DISMISSAL AND SUSPENSION

**If students do not maintain passing grades, students will be dismissed from the current course. If students do not maintain professional conduct, they will be dismissed from the coursework.**

**In addition, students may be dismissed for engaging in any of the behaviors not considered appropriate conduct in the student conduct and achievement section.**

**Any student who does not pass, or any student who is caught attempting to be dishonest with the tests, will be immediately dismissed from the program with no refund.**

**Students will be placed on academic probation, if the cumulative**

**grade falls below 80% after Block 2. Students must have a cumulative grade of at least 80% to successfully pass the EMT Course.**

## **TUITION**

**All tuition for courses is due at the time of registration. Initial Emergency Medical Technician (EMT) registration can be completed with full tuition due prior to the start of class sessions.**

**Course textbook will be provided to each student as part of tuition. This includes the textbook, access to Mylab, and HowtoNREMT test prep app.**

**Safety Unlimited, Inc. does not participate in Federal or State Financial Aid programs.**

**If a student obtains a loan to pay for their education, the student will be responsible for repaying to the loan agency the full amount of the loan plus interest, less the amount of any refund in the case of a student's withdrawal. If the student receives federal student financial aid funds, the student is entitled to a refund of the moneys not paid from federal financial aid funds. This responsibility exists whether the student completes the course(s) paid for by the loan. If a student defaults on a federal or state loan, both of the following may occur: (1) The federal or state government, or a loan guarantee agency, may take action against the student, including applying any income tax refund to which the person is entitled to reduce the balance owed on the loan, (2) The student may not be eligible for any other federal student financial aid at another institution or other government financial assistance until the loan is repaid.**



## STUDENT RECORDS

**Student records will be maintained for a minimum of five (5) years from the last date the student is enrolled at Safety Unlimited, Inc. Students may request a formal copy of their transcripts by submitting a request in writing, by either mail or email, for the period and class(es) that of which they would like a record. - 3. ### **STUDENT'S RIGHT TO CANCEL**

**"STUDENT'S RIGHT TO CANCEL"** The student has a right to cancel the enrollment agreement and obtain a refund. The institution shall, for all students, without penalty or obligation, refund 100 percent of the amount paid for the institutional charges, less a reasonable deposit or application fee not to exceed \$250.00, if the notice of cancellation is made prior to or on the first day of instruction or the seventh day after enrollment, whichever is later.
