**Public Safety First Aid and CPR Training  
Program Approval

This Public Safety First Aid (PSFA) and CPR Training Program Approval is issued by the San Joaquin County Emergency Medical Services Agency (SJCEMSA) to Safety Unlimited, Inc.

Safety Unlimited, Inc. is located at 2139 Tapo St., Suite 228, Simi Valley, CA 93063.

The PSFA and CPR training is a course designed to provide public safety personnel the ability to recognize the need for immediate care for injury or sudden illness and provide care prior to the arrival and availability of medical care by licensed or certified health care professionals. Course content shall include instructor demonstrations and student skills testing to achieve the competency standards identified in the California Code of Regulations.<sup>1</sup> This program approval allows Safety Unlimited, Inc., LLC to instruct PSFA courses in accordance with the California Code of Regulations and the policies and procedures of the SJCEMSA and the following conditions:

- A. Use the approved PSFA and CPR curriculum as set forth by the California Code of Regulations, Title 22, Division 9, Chapter 1.5 First Aid and CPR Standards and Training for Public Safety Personnel;
- B. Use only qualified teaching personnel;
- C. Issue only the approved tamper resistant course completion certificate to participants that contain the following:
  1. Indicates type of course (initial training or refresher training) and includes the number of training hours completed;
  2. Date of issue;
  3. Date of expirations (shall be two (2) years from the date of course completions).
- D. Maintain course records for four (4) years to include:
  1. Names of trainees and the dates on which training courses have been completed for at least four (4) years.
  2. Complete outlines for each course given, including a brief overview, instructional objectives, comprehensive topical outline, method of

- evaluation and record of participants performance;
3. Record of time, place, and date each course is given;
  4. A curriculum vitae or resume for each instructor;
  5. A roster signed by course participants;
- E. Make all program records available to SJCEMSA upon request;
- F. Allow SJCEMSA representatives access to observe and audit any and all courses;
- G. Notify SJCEMSA within thirty calendar days of any change in name, address, telephone number of the program director;
- H. Submit all course advertisements to SJCEMSA. Such advertisement clearly state:
1. Course tuition including books and material costs;
  2. The program's refund policy;
  3. A clear, concise description of the course, and intended target audience;
  4. The name of approved training program "Safety Unlimited, Inc.";
  5. The following statement: "This course is not approved for California EMS Continuing Education."
- I. Provide SJCEMSA with the date, time, and location of each course.
- J. Pay annual monitoring fee as established by the San Joaquin County Board of Supervisors.
